Additional details relating to the baseline year calculations

As an organisation, Truline CIS has seen sustainable growth over the past 2 years and as such, we are recording 2022 as our baseline year for carbon reduction calculations.

We recognise and understand the importance of protecting the environment in which we operate and as such, we are dedicated to minimising the impact that our business has on the environment through reducing emissions across the services we provide and through ensuring our supply chain match our aims and ethos.

As a sustainable and ethical business, we have worked hard over the past year to look at alternative ways of carrying out the services we provide to ensure that we are minimising carbon impact on the environment, which is also in line with our ISO 14001 certification.

We are committed to supporting the local communities in which we serve and for all new contracts, we implement Environmental Action Plans that are specific to each client and area in which we are working.

This is flowed down to our subcontractors and supply chain to ensure that our impact is reduced throughout the life cycle of our works. In addition, we have been exploring new and innovative ways to reduce impact through technology, electric fleet and innovations.

Since the COVID-19 pandemic, we have already reduced our impact through utilising technology such as Zoom and Microsoft Teams to conduct meetings where possible, providing a reduced footprint for business travel, ensuring impact is minimalised, whilst we also encourage our clients, suppliers, and other stakeholders to do the same.



However, as a construction and interior services provider, we understand that we will need to look at many ways to ensure carbon reduction across the business, with a need to offset some carbon emissions in the short term to our 2050 net zero goal. As such, we have carried out many initiatives over the past 12 months, which have contributed to our reduced impact.

Truline CIS will comply with all relevant legislative, regulatory, and other environmental requirements in order to act in a socially responsible manner and we will strive to continuously improve our environmental performance to protect the environment and prevent impact from our business activities.

Truline CIS has completed a detailed review of its carbon emissions during 2022 in line with SECR requirements and has chosen the year 2022 (January 2022 – December 2022) as its baseline year. The business feel that this accurately reflects the ongoing operations.

Truline CIS monitors key Scope 3 emissions, in accordance with Greenhouse Gas Protocols Corporate Accounting and Reporting Standards and will expand upon this scope in future years.

To support this, we will look at working with a specialist Consultant within the next 12-24 months to work alongside us and further reduce our carbon footprint, expanding the Scope 3 carbon emissions evaluated, and to agree and

implement initiatives, ensuring controls are put in place to monitor the effectiveness of these initiatives in an open and transparent manner.

Categories 4 (upstream transportation and distribution) and 9 (downstream transportation and distribution) have been excluded as the data is not available. We will work with our internal ESG team and chosen consulting partner to consider whether category 4 and 9 emissions could be captured through changes in process and cost allocation software.

Covid-19 caused disruption to Truline CIS's planned Energy Efficiency Actions. Larger scale projects will be assessed based on our current portfolio and impact on our current carbon initiatives. There has been continued focus to promote carbon reduction across our organisation and within our supply chain.

Business travel has continued to reduce as we encourage more meetings to be held using video technology to support a reduction in CO2 emissions related to transport. In addition, we are currently looking into electrification of fleet to support our on-site teams in meeting further reduction targets.


EMISSIONS REDUCTION TARGETS

We project that carbon emissions will decrease over the next five years to 12.23 tCO₂e by 2033. This is a reduction of 52%

We will continue to challenge ourselves, our clients and our key suppliers to develop new ways of working to meet our Net Zero commitment (Scope 1, 2 & 3 emissions) and to have agreed initiatives verified in the future. In order, to continue our progress to achieving Net Zero, we have adopted a number of emission reduction projects:
